TREASURER'S REPORT

General Fund: Previous cash balance as of May 20, 2021 was \$8,138.89. No revenue was received. Bills presented for payment were \$11.66 SIRWA for Telspan conference call service [ck#1473] and \$95.32 Creston Publishing for publication of April meeting minutes [ck#1474]. Resulting in a cash balance of \$8,031.91 for June 17, 2021.

Special Account: Previous cash balance as of May 20, 2021 was \$129,467.90. Revenue received was \$29.51 for May 2021 interest. No bills were presented for payment. Resulting in a cash balance of \$129,497.41 for June 17, 2021.

LOSST 2008 Checking Account: Previous cash balance as of May 20, 2021 was \$32,873.39. Revenue received was \$2,473.40 City of Woodburn for February 2021 sales tax and \$7.41 for May 2021 interest. Bills presented for payment were \$4,730.00 Kosman CRP Management for brome seeding [ck#1221] and

\$24,154.50 SIRWA for Trent Denney waterline installation [ck#1222]. Resulting in a cash balance of \$6,469.70 for June 17, 2021.

LOSST 2009 Checking Account: Previous cash balance as of May 20, 2021 was \$8,791.36. Revenue received was \$2.43 for May 2021 interest. Bill presented for payment was \$1,163.50 Ahlers and Cooney, P.C. for Hofbauer condemnation appeal [ck#1354]. Resulting in a cash balance of \$7,630.29 for June 17, 2021.

LOSST 2010 Preferred Direct Savings Account: Previous cash balance as of May 20, 2021 was \$341,440.42. Revenue received was \$84.72 for May 2021 interest, \$10,004.92 City of Murray for April 2021 sales tax and \$11,739.89 City of Murray for May 2021 sales tax. No bills were presented for payment. Resulting in a cash balance of \$363,269.95 for June 17, 2021.
