TREASURER'S REPORT

General Fund: Previous cash balance as of October 21, 2021 was \$46,933.38. Revenue received was \$763.05 City of Woodburn for sponsor contribution. Bill presented for payment was \$75.00 State of lowa Auditor for remaining FY2020 audit filing fee [ck#1483]. Resulting in a cash balance of \$47,621.43 for November 16, 2021.

Special Account: Previous cash balance as of October 21, 2021 was \$15,623.80. Revenue received was \$4.10 for October 2021 interest. No bills were presented for payment. Resulting in a cash balance of \$15,627.90 for November 16, 2021.
