## TREASURER'S REPORT

**General Fund:** Previous cash balance as of August 19, 2021 was \$2,851.24. No revenue was received. Bills presented for payment were \$238.00 Auto Owners Insurance for Bonding Insurance [online payment], \$2,000.00 SIRC&D for 4<sup>th</sup> quarter project administration and financial management [ck#1478] and \$128.25 Creston Publishing for publication of July meeting minutes [ck#1479]. Resulting in a cash balance of \$484.99 for September 16, 2021.

**Special Account:** Previous cash balance as of August 19, 2021 was \$1,529.46. Revenue received was \$4.19 for August 2021 interest and \$14,086.80 USDA NRCS for grant cost share. No bills were presented for payment. Resulting in a cash balance of \$15,620.45 for September 16, 2021.

**LOSST 2008 Checking Account:** Previous cash balance as of August 19, 2021 was \$9,105.08. Revenue received was \$2.63 for August interest. Bill presented for payment was \$4,568.00 Clarke County Treasurer for ½ property taxes [ck#1225]. Resulting in a cash balance of \$4,539.71 for September 16, 2021.

LOSST 2009 Checking Account: Previous cash balance as of August 19, 2021 was \$4,363.04. Revenue received was \$534,283.62 City of Osceola transfer from bond and \$69.43 for August 2021 interest. Bills presented for payment were \$5.00 American State Bank for incoming wire transfer, \$45,000.00 HDR for Task Order #9: watershed plan update [ck#1359], \$15,500.00 SIRC&D for 4<sup>th</sup> quarter project administration and financial management [ck#1360] and \$173.50 Ahlers and Cooney, P.C. for Hofbauer condemnation appeal [ck#1361]. Resulting in a cash balance of \$478,037.59 for September 16, 2021.

**LOSST 2010 Preferred Direct Savings Account:** Previous cash balance as of August 19, 2021 was \$14,850.12. Revenue received was \$2.28 for August 2021 interest and \$11,739.90 City of Murray for July 2021 sales tax. No bills were presented for payment. Resulting in a cash balance of \$26,592.30 for September 16, 2021.

# **PROJECT SERVICE CONTRACTS**

Dave Beck, CPI, reminded the Commission that their service contracts for project management and administrative/financial management ended December 31, 2021. Beck indicated that he would submit his contract for project management at next month's meeting.

# LAND MANAGEMENT EQUIPMENT

Dave Beck explained that the SIRC&D has offered to sell their track loader/bucket (approximately 550 hours), rotary mower, land plane and auger to the Commission for \$52,000.00. After doing research on similar equipment Beck recommended that the Commission purchase the equipment from SIRC&D. Commissioner William Trickey made a motion to acquire the equipment effective the 1<sup>st</sup> of January 2022. Motion seconded by Commissioner Dan McIntosh. Motion carried on roll call vote:
