NEW BUSINESS AND CONTINUING BUSINESS

HDR REPORT

Mike Butterfield, HDR, discussed field activities conducted by HDR staff for wetland delineations and biological assessments needed for the watershed plan-EIS. Field work is complete, data analysis is underway, and report development will follow soon. The draft plan-EIS should be ready for internal HDR and CCRC review in early December. We should be on schedule to provide NRCS final draft plan-EIS in March.

PROJECT MANAGEMENT UPDATE

Dave Beck, Project Coordinator, reported that he and Ty Wheeler had worked significant time in August with NRCS on developing an amendment to the existing agreement with NRCS. The amendment will extend the completion date from December 31, 2023 to December 31, 2024 and add about \$250,000 in

federal assistance to CCRC. This will help both NRCS and CCRC complete a significant part of the work necessary to be in compliance with the National Historic Preservation Act for the project.
