NEW BUSINESS AND CONTINUING BUSINESS

HDR REPORT

Michael Butterfield of HDR Engineering reported on progress and submission of the Plan EIS to National Water Management Center for technical review. Review is expected to take 45-50 days. Following the review, HDR will go over questions and comments with Iowa NRCS. The report will then be submitted for NRCS Programmatic Review which is expected to take 30 days. Public and agency review is expected in Late 3rd Quarter 2025. Following that review, NRCS should be able to approve the Plan EIS. CCRC should then be able to apply for funding the final design work in 2026.

PROJECT MANAGEMENT UPDATE

Dave Beck, Project Coordinator, presented the EIS report that was sent off to the NRCS National Water Management Center and gave an update on meetings held with Tallgrass Archaeology, HDR Engineering, Inc., Iowa DNR, and Bud & Justin Jones, from February 27, 2025 thru March 26, 2025. Iowa DNR will be doing field work and providing assistance with a Draft Land Management Plan for completion Winter 2026.

CCRC approved a policy prohibiting public access on 11/19/2020.
