# CLARKE COUNTY RESERVOIR COMMISSION Regular Meeting Minutes Thursday, April 24, 2025. Approved

## **NEW BUSINESS AND CONTINUING BUSINESS**

#### HDR REPORT

Michael Butterfield of HDR Engineering reported on progress of the Plan EIS at National Water Management Center. Review is in process and expected to take approximately 50 days. Following the review, HDR will go over questions and comments with lowa NRCS. The report will then be submitted for NRCS Programmatic Review which is expected to take 30 days. Public and agency review is expected in Summer/Fall 2025. Following that review, NRCS should be able to approve the Plan EIS. CCRC should then be able to apply for funding with expected design work in 2026.

Commissioner William Trickey-City of Woodburn asked who the final approver is: the NRCS Chief is the final Plan EIS approver.

Commissioner Brandon Patterson-Osceola Water Board asked how long the Plan EIS is good for: the Plan EIS is good for a period of 5 years.

HDR Field work regarding Wetland & Stream Mitigation is planned for May and Bat Habitat Surveys will done in April, May & June.

CONSIDERATION AND POSSIBLE ACTION REGARDING PROGRAMMATIC AGREEMENT AMONG THE US

DEPARTMENT OF AGRICULTURE, NATURAL RESOURCES CONSERVATION SERVICE IOWA STATE OFFICE, CLARKE
COUNTY RESERVOIR COMMISSION, AND THE IOWA STATE HISTORIC PRESERVATION OFFICER, REGARDING
PHASED IDENTIFICATION AND EVALUATION OF HISTORIC PROPERTIES FOR THE CLARKE COUNTY WATER SUPPLY
PROJECT

Chairperson Ty Wheeler, presented the Programmatic Agreement Among the USDA, NRCS-IA, CCRC, and IA SHPO regarding phased identification and evaluation of Historic Properties for the Clarke County Water Supply Project.

Dave Beck, Project Coordinator, presented a Summary of the Programmatic Agreement. The Agreement establishes the Area of Potential Effect (APE) which may be changed as plans & designs are completed. There are 8 undertaking phases that need to be cleared. NRCS will prepare reports for SHPO for each of the 8 phases as well as a Summary of the phases. Once the phases are cleared individually, the project will be cleared collectively. Procedures must be followed in the case of inadvertent discoveries or the discovery of human remains. The Programmatic Agreement is good for 10 years and requires annual reports from CCRC and NRCS describing the progress of implementation of the agreement. Signatories are required from NRCS and IA SHPO. Signatories are invited from CCRC. Concurring Party Signatories from lowa Office of the State Archaeologist, Flandreau Santee Sioux Tribe, and lowa Tribe of Kansas and Nebraska.

Commissioner William Trickey-City of Woodburn asked about discoveries: contracts with Tallgrass Archaeology, LLC will provide information of any significant discovery sites.

After discussion, Commissioner William Trickey-City of Woodburn made a motion to approve that Programmatic Agreement as presented. Commissioner Brandon Patterson-Osceola Water Board seconded the motion. Motion carried on roll call vote:

## PROJECT MANAGEMENT UPDATE

Dave Beck, Project Coordinator, gave an update on meetings held with NRCS, HDR, IA DNR Wildlife Bureau staff and CCRC Lobbyist: trying to get in touch with Representative Nunn's office but no meetings are scheduled yet. Would like to burn some prairie reconstruction tracts but the weather has not cooperated. HDR is working on cost estimates for future Plan EIS approval.

## OTHER ISSUES TO BE DISCUSSED BY COMMISSION MEMBERS

Commissioner Brandon Patterson – Osceola Water Board had questions regarding when the demolition of the former Snyder Property could occur and asked questions regarding the land where a future water storage tank would be located.
